

MINUTES OF THE REGULAR MEETING OF THE FRANKFORT BOARD OF THE FIRE AND POLICE COMMISSIONERS

WEDNESDAY, AUGUST 15, 2018

CALL TO ORDER AND ROLL CALL

The regular meeting of the Frankfort Police Commission was called to order at 8:02 a.m. on August 15, 2018 at the Frankfort Village Hall 432 W. Nebraska St. Frankfort, IL 60423.

Roll Call was taken by Chairman Kelley and Commissioner's Sunderland and Fanizzo were in attendance. Police Chief John Burica and Officer Joe Sroka represented the Police Department.

APPROVAL OF MINUTES

The minutes of the meeting of April 2, 2018 will be approved at the next regular meeting.

CHAIRMAN'S REPORT

Commissioners Kelley and Fanizzo attended an Illinois Police Commissioners Associations Training seminar in Bloomington, Illinois on May 4-5 of 2018.

CHIEF'S REPORT

The District 157 School Board voted to pay partial salary for a School Resource Officer.

Officer Martello continues to progress.

PPO Tinman graduated from the police academy.

Officers Mineo and Sroka have been appointed as detectives due to Sargents Jaicomo and Johnson promotions.

NEW BUSINESS

Candidates will be required to complete and pass fitness testing after Oral Boards and prior to background investigations. Candidates may be removed from list prior to interviews based on background checks.

Discussed whether to move several certified candidates up from second half of list.

OLD BUSINESS

Status of new hire process:

Background check on six candidates have been completed.

1. Candidate # 1 is non-certified, currently working as a police dispatcher, good background check and polygraph results. Speaks English and Spanish and is deemed a strong candidate.
2. Candidate # 2 is non-certified, currently working as a Loss Prevention Officer, no police background, studied criminal justice, good background check and polygraph results, is bi-lingual. Had some driving infractions when younger.
3. Candidate # 3 is non-certified, currently working as a vet tech. Has questionable background.
4. Candidate # 4 is currently a certified police officer, has a questionable background, polygraph results were not positive.
5. Candidate # 5 is currently a Chicago Police Officer and removed himself from the list because his pension would not transfer.
6. Candidate # 6 withdrew from list to attend law school.

Candidates #22 and #24 have been removed from the list based on background check information.

Interviews for first two candidates will be 6:00 p.m. 8/17/18.

Candidates psychological test are scheduled for August 21, 2018.
